ETD2017, the 20th international symposium on electronic theses and dissertations will be held August 7 – 9, 2017 at the [Embassy Suites Hotel](#) in Washington, D.C. The conference will be hosted by George Mason University with additional support from Washington Research Library Consortium members and co-organized by the Networked Digital Library of Theses and Dissertations (NDLTD) and the United States Electronic Thesis and Dissertation Association (USETDA).

ETD2017 will provide excellent educational opportunities for professionals from graduate schools, libraries, academic computing and others who work with electronic theses and dissertations (ETDs), institutional repositories, graduate students and scholarly communications. Our goal is to offer relevant, practice-oriented content to support ETD productivity improvement, ETD professionals, advance ETD operations and encourage the formation of regional ETD associations and networking communities, to promote open access in scholarly communications as well as to provide useful and innovative resources, standards, and technology for the development and support of ETD programs.

Background: From 1998 on interested institutions in the United States began meeting annually for what would become a series of symposia on electronic theses and dissertations sponsored by NDLTD and designed to help universities initiate ETD projects. The first ETD Symposium was held in at the University of Tennessee Health Science Center (Memphis) in 1998, since then, the annual conferences were hosted at universities all around the world, with the first European venue being Humboldt University in Berlin, in 2003. More recently, ETD Symposia have been held in Sydney, Australia; Aberdeen Scotland, Pittsburgh, Pennsylvania; Cape Town, South Africa; Hong Kong; Austin, Texas; Uppsala, Sweden; Lima, Peru; Leicester, UK and New Delhi, India. ETD2016 was hosted by the [University of Lille](#), France from July 11-13, 2016.

In his keynote address "Re-thinking Institutional Repositories and Evolving Ideas about ETDs" Lynch will talk about the role of institutional repositories and ETDs, critical assessments and directions for the future.

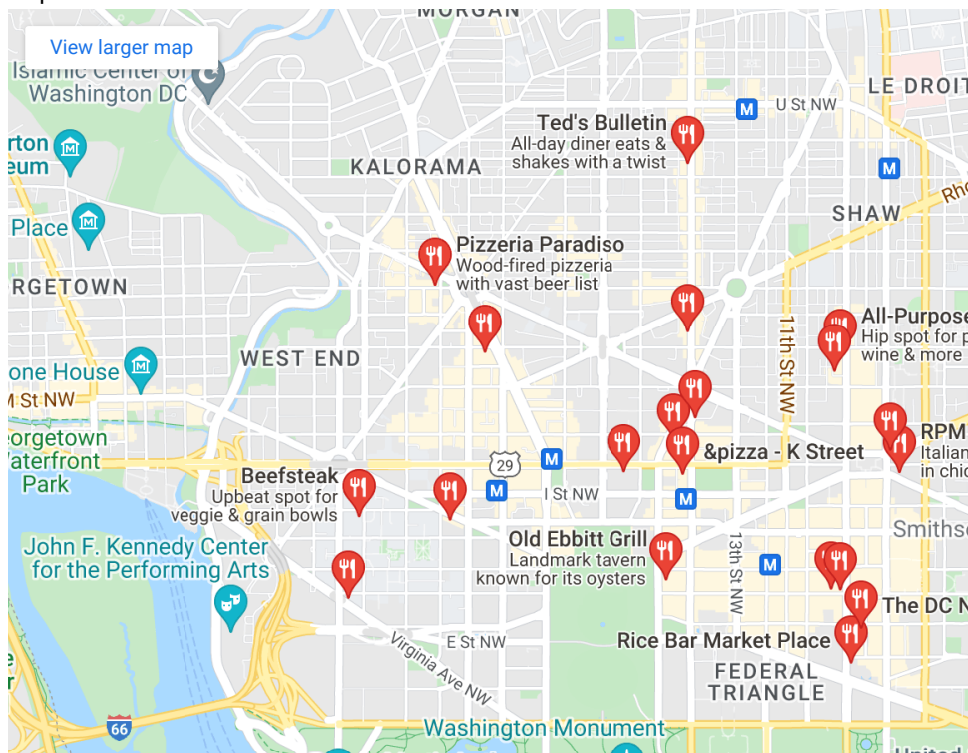

Streamlining ETD Processing using Vireo 4.0 Open Source ETD Submission and Management System



Presented by Stephanie Larrisor – Electronic

In most institutions around the world, thesis and dissertation processing makes up just a fraction of the job duties of graduate school and library professionals. However, an ETD submission and management system is a great tool that streamlines workflows and makes processing even more efficient. In this workshop, we will introduce Vireo 4.0, the latest version of the open source Vireo ETD Submission and Management web application scheduled for release in summer of 2017. This workshop is intended for anyone interested in ETD submission systems as well as current Vireo users.

In the first hour, the presenters will provide a broad overview of Vireo, describing what it does, what it integrates with, and how it saves time and duplication of effort for student, graduate school professionals, librarians, and repository managers.

Existing Vireo users may choose to enter at the second hour when we demonstrate the new and powerful features of Vireo 4.0 that make it the most flexible and customizable ETD submission system available today.

Learning outcomes include:

- Familiarity with the basic functions of Vireo from student and staff perspectives
- Familiarity with the new organizational structure of Vireo and the creation of workflows
- Understanding of how to apply controlled vocabularies to select fields
- Strategies to create new workflows for more efficient ETD processing

Managing and Preserving Data and Complex Digital Objects Workshop



Presented by [Sam Meister](#) – Preservation Communities Manager at the Educopia Institute and [Katherine Skinner](#) – Executive Director of the Educopia Institute.

In a 2014 survey of 795 graduate students across nine U.S. universities conducted by the ETDplus project team, more than a third of respondents reported that *non-PDF files* created in their thesis and dissertation research process – including research data, video, digital art, and software code – are either *as important or more important* than the PDF as research outputs and evidence. Only 20% of these respondents reported that they were not

Recent reports, workshop evaluations, projects, surveys, and focus groups have indicated that internationally, colleges, universities and ETD/IR programs of all sizes are requesting and in need of generalized yet adaptable guidance documentation, shared curatorial technologies, and corresponding training materials to bridge the preservation and curatorial gap for these valued scholarly assets.

This three-hour workshop will help ETD program administrators and the libraries that support them to understand and address students' needs to ensure the longevity of the research outputs. Together in the workshop, we'll discuss current and near-future needs and ways that ETD programs can help to narrow the gaps in knowledge, expertise, and infrastructure for our students.

The workshop will draw upon research and content produced in the IMLS-funded "ETDplus" project (Educopia, 2014-17) including its openly reusable and adaptable student-oriented Guidance Documents and workshop series, and also a prototype tool built in Hydra Sufia that is designed to support student ETD supplementary materials submission.

- Understand what other institutions are doing to support students in managing (or learning how to manage) their research outputs.
- Practice using a prototype tool designed to support student ETD supplementary materials submission.

NDLTD Travel Scholarship Program

Travel grants for delegates to attend the ETD annual symposium are an investment in ETDs worldwide. The NDLTD believes it is important that delegates from all nations have an opportunity to attend the annual conference and generally provides funding (amount varies) for scholarships. Final decisions about Travel Scholarship awards are the responsibility of the ETD2017 Local Conference Organizing Committee.



Program Guidelines:

- Scholarships may be provided for: travel, lodging, and/or conference registration fees.
- To receive travel funding a candidate must be from a developing country and must provide a letter of support from their superior noting that the conference is of particular interest to the institution. The applicant must also provide a short (two to three page) report on follow up plans to implement an ETD program at their institution.
 - Check to see if your country is listed in the [UN Developing Countries list](#) to confirm eligibility.
- Since funding for travel grants is scarce and in order to ensure that as many institutions in developing countries as possible are able to benefit from attending the ETD annual symposium, the Local Conference Organizing Committee should ensure that, except in very special circumstances, the same institution does not receive a travel grant to more than one symposium. Requests for second time funding should be referred to the NDLTD Conference Standing Committee for review and consideration. The same guideline applies to individuals applying for second time funding whether they are at their original institutions or have moved to a new one.
- The candidate's institution must be willing to provide some portion of the travel budget at least equivalent to the domestic portion of the trip.
- Candidates for lodging support need not necessarily be from developing countries, but must demonstrate need of financial support. Where lodging support is provided this will be at whatever level is deemed appropriate by the Local Conference Organizing Committee.
- Conference registration fee scholarships should be available to any candidates deemed appropriate. These scholarships may be full scholarships (waiver) or partial scholarships (reduced fees). For planning purposes, the Local Conference Organizing Committee may want to designate how many conference fee scholarships are feasible given a certain level of registration. These scholarships may be helpful in promoting the conference with local institutions which would like to send more than one person but which cannot afford full price for all of them.
- Please provide a letter of support from a senior member of staff confirming that your attendance at 'ETD2017' would be of benefit to your institution. Reference letters (preferably a scanned copy (PDF) on institutional letterhead) should be sent to info@usetda.org.
- The Local Conference Organizing Committee has established a process for evaluating and awarding the scholarships which allows for fair review but also provides sufficient time for the recipient to make travel plans. **The deadline for application submissions is March 31, 2017. Recipients will receive notification by April 21, 2017.**
- At the time recipients of travel grants submit their final expense claims to the Local Conference Organizing Committee they are also required to submit a short (one

page) report on how attendance benefited them and what action(s) they will be able to implement at their home institutions. Outstanding expense claims must not be settled until the reports are received. Note that the requirement to submit a report applies to all recipients of travel grants even if their expenses were paid before the conference. Reports must be submitted no later than three months after the conference has taken place and the Local Conference Organizing Committee should indicate a specific deadline on the application. The reports will be made available to sponsoring organizations if requested.

- Funds will be disbursed upon presentation of original receipts with expense reports on a reimbursement basis only. No cash advances will be provided. Scholarship recipients must attend the conference to receive reimbursement.
